6. Transfer/Issue/Acquisition/Redemption of Shares	24 hours

C. Industrial Property Services

CIPA, through the Industrial Property Act, is mandated to protect intellectual property rights in relation to patents, trademarks, utility models, industrial designs, geographical indications, layouts of integrated circuits, handicrafts and traditional knowledge.

1. Renewal of a Trademark	5 days	
Application to register a utility model	8 days (3 days of examination and 5 days of grant)	
Application to register an industrial design	8 days (3 days of examination and 5 days of registration)	
4. Application to register a trademark	5 months (Including 3 months mandatory publication)	
5. Application to register a Patent	12 months (substantive examination conducted by the African Regional Intellectual Property Organisation in Harare, Zimbabwe).	

D. COPYRIGHT

The Authority is mandated with the administration of the Copyright and Neighbouring Rights Act, which protects artistic and literary works, including, amongst others, music, film, photography, drama, poetry, art, softwares, apps and architecture.
